- Review most recent 2020 preliminary appraised values from Hays County Central Appraisal District, review
 of the existing residential homestead tax exemption for individuals disabled or 65 or older, review of
 anticipated operating budget items for current and upcoming fiscal year, and hear report from the Board
 Finance Committee regarding recommendations for tax exemptions and rates;
- 3. Consideration and possible action with respect to:
 - a. Previously adopted tax exemption under Section 11.13(d) of the Texas Tax Code for individuals disabled or 65 or older;
 - b. Previously adopted tax exemption under Section 11.13(n) of the Texas Tax Code for all individuals based on percentage of the appraised value of residence homestead; and
 - c. If necessary in consideration of any actions taken with respect to the foregoing items, approval and execution of new Order Adopting Residential Homestead Exemptions and authorization to file such Order with the Hays Central Appraisal District and the Hays County Tax Collector;
- 4. Consider adoption of amended Order Adopting an Investment Policy and Appointing Investment Officers;
- 5. Update as to status of approval of 9th bond application by the Texas Commission on Environmental Quality ("TCEQ") of the District's \$6,380,000 Unlimited Tax Bonds ("Series 2020 Bonds"), consideration and possible action with regard to authorizing the sale of bonds pursuant to a private placement in lieu of a public offering, and preparation of a Notice of Sale and Limited Offering Term Sheet and Bid Form in lieu of a Notice of Sale and Preliminary Official Statement;
- 6. Authorize the opening of a Series 2020 Capital Projects Account and any other accounts as may be necessary in connection with the seal of such Series 2020 Bonds;
- 7. Consideration and possible action with respect to proposal for removal of bookkeeping services from scope of operations and management agreement with Inframark LLC;
- 8. Consideration and possible action with respect to matters relating to the West Travis County Public Utility Agency;
- Adjourn to Executive Session to consult with attorney regarding pending litigation matters, contemplated or
 potential litigation matters, and other legal matters related to agenda items in accordance with Texas
 Government Code § 551.071;

10. If necessary, reopen meeting and take any necessary action with regard to matters discussed in Executive Session; and

11. Adjournment.
