- Consideration and possible action regarding proposed engagement letter with Maxwell Locke & Ritter LLP with regard 5. to the preparation of the District's audit for its fiscal year ending September 30, 2020;
- 6. Adjourn to Executive Session to consult with attorney regarding pending litigation matters, contemplated or potential litigation matters, and other legal matters relating to agenda items in accordance with Texas Government Code §

Consideration and possible action with respect to opening of new accounts, closing of existing accounts, addition and removal of signatories on accounts, new signature cards, approval of necessary transfers and disbursements and such other bookkeeping and financial items as are recommended for approval by the District's bookkeeper
