  - (b) Discussion and possible action with respect to necessary landscape and greenbelt cleanup activities after recent ice storm, including without limitation consideration of additional proposals for further storm cleanup activities in irrigation areas.
  - (c) Update with respect to FEMA and TDEM applications for reimbursement of storm debris cleanup costs associated with winter ice storm.
  - (d) Update with respect to landscaping map and authorization of Parks Committee to work with operator, landscaper and engineer to propose adjustments to mowing schedules.

- (e) Review of TDS solid waste collection contract matters and possible updates to rates to be charged to the District.
- (f) Update with respect to Belterra Centre repairs and upgrades.
- (g) Approve and ratify authorization of emergency expense to obtain replacement submerged membrane units for wastewater treatment plant.
- (h) Discussion and possible action regarding water conservation and drought contingency matters.
