# AREAS OF CONCERN



**Clean up Status:** Due to the significant impact of the February 2023 storm, the storm cleanup continues to be an ongoing effort. Progress is being made. Both Districts initially focused on clean-up of safety issues, roadways, sidewalks, trails and parks. The trails were made passable by temporarily moving brush aside. Now crews are focused on removing debris along trails. Crews have also been focused on cleaning up debris from the districts' extensive irrigation fields which are critical to district infrastructure. The districts expect the cleanup effort to continue through the summer.

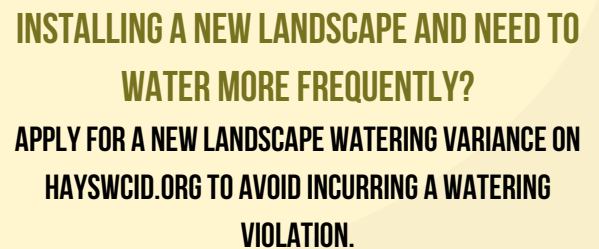
## HAYS COUNTY WCID NO. 1 RESIDENTIAL WATER SCHEDULE
