## What's Going on at Belterra Dr. and Sawyer Ranch

#### **Reclaimed Water Area**

As the Community grows, our need to add more reclaimed water space grows, too. You may notice the clearing and trench work that is happening along Belterra Dr. on the right past Seneca Section. The District is adding around 30 acres of reclaimed water irrigation area.

Hays WCID began using reclaimed water for landscape irrigation along Belterra Dr. and Trinity Hills Dr. several years ago. Our beneficial reuse program utilizes reclaimed water treated to some of the highest levels in the state and can be used for non-potable applications in place of potable water or as a supplement to potable water.

Reclaimed water helps the community of Belterra conserve water for use into the future. It is a cost-effective way to improve the Districts' ability to provide water for non-drinking water purposes and ensure water will be available even during times of drought.

### **Sidewalk Project**

Construction has started in along Belterra Dr. to add a sidewalk that will eventually connect to the Hays County sidewalk on Sawyer Ranch Rd.

### **New Outdoor Watering Schedule**

Belterra's water provider, the West Travis County Public Utility Agency (WTCPUA), sent notice that they are experiencing significantly higher water demands related to the lack of rainfall and recent high temperatures. The water demands are primarily during overnight hours and related to landscape irrigation. The increased water demands have made it difficult to manage the delivery of domestic water. To balance the needs of customers while maintaining a safe, reliable public water system, the WTCPUA is revising the twice a week **MANDATORY** watering **RESTRICTIONS** schedule as set forth below, effective immediately:

Residential Customers are allowed to use water for outside irrigation only on the following days, based on their address:

- Monday & Thursday Addresses ending in 0,1,2,3
  - Tuesday & Friday Addresses ending in 4,5,6
- Wednesday & Saturday Addresses ending in 7,8,9
  - No outdoor watering allowed on Sundays

Watering Times are: 12:00 a.m. to 10:00 a.m. and/or 7:00 p.m. to Midnight.
