# TO: THE BOARD OF DIRECTORS OF HAYS COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NO. 2 AND TO ALL OTHER INTERESTED PERSONS:

Notice is hereby given pursuant to Section 551 of the Texas Government Code that the Board of Directors of Hays County Water Control and Improvement District No. 2 will conduct a Regular Board meeting at 5:45 p.m. on Thursday, September 21, 2023 for the purposes stated herein. Members of the Board and members of the public may attend the meeting in person at the Belterra Centre, 151 Trinity Hills Drive, Austin, Texas.

- 1. <u>PUBLIC COMMENT</u>: Hear public communications and comments (3 minutes per person; no action may be taken during public comment).
- 2. <u>PUBLIC HEARING ON 2023 TAX RATE</u>: Open, conduct and adjourn Public Hearing on 2023 Tax Rates.
- 3. <u>MEETING MINUTES</u>: Review and approve the Minutes for the August 17, 2023 Regular Meeting and August 31, 2023 Special Meeting.

## 4. FINANCIAL:

- a) <u>Budget and Tax Matters</u>:
  - i) Review and approve Resolution Approving Operating Budget for fiscal year ending September 30, 2024.
  - ii) Review and approve Resolution Approving Debt Service Budget for fiscal year ending September 30, 2024.
  - iii) Review and approve Order Setting Tax Rates for 2023 and authorize filing and posting of same.
- b) <u>Accounting Report</u>: Review and approve Accounting Report including the review and approval of the Cash Activity Report, director and vendor payments, fund transfers, tax collections, investment reports, opening and closing of bank accounts, signature authorizations, collateral related authorizations, account related matters and Financial Statements and take necessary actions related to such matters.
- c) <u>Arbitrage Rebate Summary</u>: Review and acknowledge receipt of Arbitrage Rebate Summary Active Issues for Rebate Purposes received from Arbitrage Compliance Specialists.
- d) <u>Administrative Items</u>: Consideration and possible action on administrative items, including opening and closing of accounts, approval of new signature cards and such other bookkeeping and financial items as are recommended for approval by the District's accountants, including without limitation application to open new TexPool investment account.

## 5. <u>LANDSCAPING</u>:

- a) Hear report from landscaper with respect to routine landscaping or additional landscaping projects in the District as may be proposed (with any necessary action to be taken under the General Manager's Report).
- b) Update and possible action with respect to necessary landscape and greenbelt cleanup activities after recent ice storm.
- c) Update and possible action regarding submission of claim to TDEM and FEMA for reimbursement of costs incurred in responses to ice storm emergency.
- d) Discussion and possible action regarding trail maintenance and any necessary repairs.

# 6. <u>ENGINEERING</u>:

- a) <u>WWTP Joint Facility Report</u>: Consider and approve District Engineer's WWTP joint facility report and take any action as necessary with respect to matters relating to the on-going projects at the WWTP, recommended actions or any additional authorizations, engineering task orders, pay estimates or change orders on existing contracts, substantial or final completion of projects, and other items included in such report.
- b) <u>District Report</u>: Presentation of Engineer's Report with regard to general engineering matters relating to existing system operations and design, plat approvals, utility easements, permitting matters and ongoing construction projects; approve the advertisement and taking of bids for additional phases of grading, roads and utilities, contract awards related thereto and approval and ratification of pay estimates and change orders presented to the Board relating to construction of facilities; if timely, approve recommendations for final acceptance of projects, consideration of any matters relating to engineering contracts, task orders or invoice matters, review any updates to irrigation water schedules and such other engineering matters that may come before the Board, and take all necessary actions related to such matters.

# c) Action Items:

- i) Consideration and possible action with respect to final matters related to closeout of trail extension project.
- ii) Update and possible action regarding liner installation project to repair and enhance existing reclaimed water irrigation main lines.
- iii) Discussion and possible action regarding matters related to WTCPUA system pressure issues and potential options for mitigating future occurrences.
- iv) Consideration and possible action regarding temporary adjustment of irrigation schedule for certain neighborhoods within the District to evaluate effects on system pressure.

v) Authorization of recommended expenditures and actions related to improvement, repair, maintenance of District property and facilities and such engineering matters as are recommended for action.

# 7. <u>MANAGEMENT AND OPERATIONS</u>:

- a) Manager's Report: Review and approve General Manager's report regarding on-going operations activities, committee matters, parks and trails, landscaping related services, customer care, finance, contractual and joint facilities reports, and receive updates as to operations and resident communications; conduct hearings with respect to violations of District Rules, if any, and discuss and take action on enforcement and remedial measures available to District and take necessary action with respect thereto; approve customer write-offs as necessary; consider and approve adoption of revised system and/or park rules and regulations, if necessary; take any action on needed water conservation and drought contingency measures; review any needed updates or revisions or rate adjustments to exiting Service Rate Order, and take any action on these and other operational matters as may be necessary.
- b) Conduct hearings with respect to reported violations of District rules and regulations observed on District open space property, as set forth in notices of violation issued to residents, and take any necessary action in connection therewith. Residents to whom a notice of violation has been issued will be permitted an opportunity to contest the violations.
- c) Discussion and possible action regarding request by resident for approval to use the District's landscaper to prune some trees in the greenbelt area by his home at his expense.
- d) Update with respect to interlocal agreement regarding law enforcement and take any necessary action.
- e) Update with respect to emergency expense to obtain replacement submerged membrane units for wastewater treatment plant

# f) Action Items:

- i) Discussion and possible action regarding remaining storm debris removal efforts related to ice storm.
- ii) Authorization of recommended expenditures and actions related to improvement, repair, maintenance of District facilities and property, ongoing projects and such routine management and operational matters as are recommended for action.

## 8. ADMINISTRATIVE AND LEGAL:

a) <u>Water Contract Items</u>: Consideration and possible action on matters related to existing agreements for water supply with the Lower Colorado River Authority and water service through the West Travis County Public Utility Agency ("PUA"), water rates and water conservation matters.

b) <u>Water Conservation and Drought Contingency Plan</u>: Consideration and possible action with respect to reported violations of Water Conservation and Drought Contingency Plan, and take any other necessary action with respect to such Plan.

# c) <u>Legal Matters</u>:

- i) Discussion and possible action with respect to modification of landscaping and operation and maintenance contracts to address moving of pond areas.
- ii) Discussion and possible action with respect to proposed resolution establishing committees and adopting committee administration policy.
- iii) Discussion and possible action with respect to proposed policy related to trimming of trees in District greenbelt areas.
- d) <u>Calendaring</u>: Schedule or confirm any proposed additional special board meetings, committee meeting dates and upcoming conferences and registration for same
- 9. <u>EXECUTIVE SESSION</u>: Adjourn to Executive Session to consult with attorneys regarding pending litigation matters, contemplated litigation matters, and other legal matters related to agenda items in accordance with Texas Government Code § 551.071. If necessary, reopen meeting and take any necessary action with regard to matters discussed in Executive Session.

## 10. <u>ADJOURNMENT</u>.

Note on Executive Session: The Board of Directors will go into Executive Session, if necessary and appropriate, pursuant to the applicable section of subchapter D, Chapter 551, Texas Government Code Annotated, the Texas Open Meetings Act, on any matter that may come before the Board. No action decision or vote on any subject or matter may be taken unless specifically listed on the agenda for this meeting.

Note on Public Comment: Any Person wishing to address the Board **generally** will be permitted to present comments at the time the presiding officer calls for public comments in accordance with the meeting notice. Any Person wishing to address the Board with respect to a **specific agenda item** will be permitted to present comments before or during the Board's consideration of the agenda item, at the discretion of the presiding officer.
