

HAYS COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NO. 2

TO: THE BOARD OF DIRECTORS OF HAYS COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NO. 2 AND TO ALL OTHER INTERESTED PERSONS:

Notice is hereby given pursuant to Section 551 of the Texas Government Code, that the Board of Directors of Hays County Water Control and Improvement District No. 2 will conduct a special meeting jointly with the Board of Directors of Hays County Water Control and Improvement District No. 1 at 5:00 p.m. on May 12, 2026, at Belterra Centre, 151 Trinity Hills Drive, Austin, Texas, for the purposes stated herein.

1. Public Comment. Hear public communications and comments (3 minutes per person; no action may be taken during public comment).
2. Water Storage Facility Engineering Plans. Discussion and possible action regarding engineering plans and permitting for water storage facility and such other engineering matters as are recommended for action.
3. Water Storage Facility Administrative and Legal Matters. Discussion and possible action regarding administrative and contractual matters related to construction and operation of water storage facility including, without limitation, the following items:
 - (a) Proposed Amendment of Joint Facilities Agreement between the District and Hays County Water Control and Improvement District No. 1;
 - (b) Proposed Amendment of Interconnection Agreement between the District and Hays County Water Control and Improvement District No. 1;
 - (c) Proposed Reclaimed Water Irrigation Lease between the Hays County Water Control and Improvement District No. 1 and Dripping Springs Independent School District;
 - (d) Proposed Amendment of Water Service Agreement between the District and West Travis County Public Utility Agency; and
 - (e) Other agreements as may be necessary or appropriate.
4. Water Storage Facility Construction. Discussion and possible action regarding advertisement and bidding of water storage facility construction project upon receipt of necessary approvals and review of updated project schedule.
5. Executive Session. The Board may recess into Executive Session at any time to consult with its attorneys regarding any posted matter for which the Board may seek the advice of its attorneys under Government Code 551.071 (including without limitation contemplated or potential litigation matters, and other legal matters related to agenda items) or for any action on the agenda for which a closed session is permitted by law, and will reconvene in open session for any appropriate action on any matter considered in Executive Session.

If necessary, reconvene in Open Session and take action with regard to matters discussed in Executive Session.

6. Adjournment of Regular Board Meeting.

Note on Executive Session: The Board of Directors will go into Executive Session, if necessary and appropriate, pursuant to the applicable section of subchapter D, Chapter 551, Texas Government Code Annotated, the Texas Open Meetings Act, on any matter that may come before the Board. No action, decision or vote on any subject or matter may be taken unless specifically listed on the agenda for this meeting.

Note on Public Comment: Any Person wishing to address the Board will be permitted to present comments at the time the presiding officer calls for public comments in accordance with the meeting notice.
